- 7. ORDINANCE NO. 1493 NOISE ORDINANCE AMENDMENT Mayor Damiano noted there have been some changes to this as it was previously addressed. Council President SGOBBA reiterated one of the modifications which provided clarifications regarding what work is permitted on Sundays.
- ORDINANCE NO. 1495- ADDING CHAPTER 152 (PEDESTRIAN PLAZAS) Mayor Damiano discussed the intent to complete the streetscape along Stevens Avenue over the summer months and then add a pedestrian plaza along Warren Street. At this time, Mike Kobylarz, Township Engineer, presented and described in detail a proposed plan which would provide a pedestrian friendly area connecting the old municipal building to the Library. Mr. Kobylarz also discussed his evaluation of parking in the area, summarizing there would be a net increase of five parking spaces. Mr. Kobylarz further elaborated that as part of the pedestrian plaza improvements there would be improvement in the parking area around the old municipal building. Council President SGOBBA emphasized this is a proposed plan. Mr. Kobylarz responded to Council President SGOBBA that the cost has not been evaluated at this time. Also in response to Council President SGOBBA, Mayor Damiano discussed funding of the project, and emphasized that this is only a proposal and other parties would be included in consideration of the project.

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 – to wit:

R.S. 52:27BB-52 – "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order

of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office

<u>Ed Rich</u> – questioned what would occur to Mr. May's driveway after a heavy snowstorm and commented on the location of the Farmers Market. Council President SGOBBA responded to snow removal and stated the Farmers Market may be relocated. Mayor Damiano then commented on snow removal and noted it is no different than other dead-end roads in the Township.
