

LEGAL NOTICE
TOWNSHIP OF LITTLE FALLS PLANNING BOARD

PLEASE TAKE NOTICE that in accordance with the provisions of the Open Public Meetings Act pursuant to N.J.S.A. 10:4-6 et. seq. you are hereby advised that the Township of Little Falls Planning Board has made the following changes to the regularly scheduled Planning Board meeting of Thursday, May 7, 2020. The meeting will begin at 7:00 p.m. The meeting will be held remotely, by means of communication equipment and services as permitted pursuant to N.J.S.A. 10:4-9.1. Formal action may be taken at this meeting. The meeting will be limited to the following matters:

1. Theta Holding Co. LP for property located at 150 Clove Road, Little Falls, New Jersey and identified on the Township Tax Map as Block 251, Lots 10, 10.01, 11 (and contiguous Lot numbers 3, 4, 5, 6 and 16 in Block 251) and adjacent to property designated as Block 251, Lot 12 (Montclair State University). This is a continuation of the public hearing process with public hearings having occurred on February 6, 2020 and March 5, 2020. The Applicant seeks bulk variance relief pursuant to N.J.S.A. 40:55D-70c and preliminary and final site plan approval in order to develop an access/service road and related improvements to connect the Overlook Corporate Center to Yogi Berra Drive on the Montclair State University Campus.
2. The Planning Board may add other items to the Agenda for this meeting if deemed necessary including, but not limited to approval of Minutes and payment of bills.

The foregoing electronic public meeting is being conducted due to the current situation involving the COVID-19 virus and directives of State and County governments that restrict public gatherings and direct residents of New Jersey to stay at home.

The Board Chairman will give the members of the public an opportunity to make any statements at the conclusion of the public hearing process. Your questions will be acknowledged and read into the record and answered. If you have information or exhibits you wish to be considered and entered into the record, you will have to email them to James DiMaria, Construction Code Official at JDiMaria@lfnj.com in advance of the meeting no later than 24 hours from the meeting so that they may be marked into evidence. All guests will be automatically muted upon entering the virtual meeting. Guest participants that do not comply with the virtual meeting will be subject to ejection.
